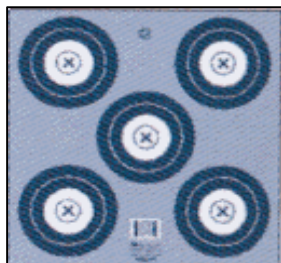

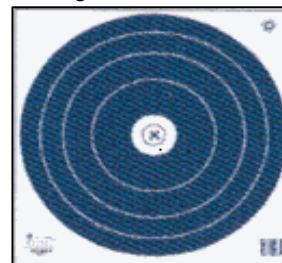

State Association Waiver and Release of Liability
Read Before Signing

In consideration of being allowed to participate in any way in Connecticut Archery Association events and activities, the undersigned acknowledges, appreciates, and agrees that:
